### Background

The Australian Government established the Commercial Building Disclosure (CBD) program under the *Building Energy Efficiency Disclosure Act 2010* (BEED Act). The program has successfully reduced the energy consumption of commercial offices and has been in operation since 2010.

The current program mandates that building owners (that are constitutional corporations) wishing to sell, lease or sublease office buildings over 1000 sqm must have a valid Building Energy Efficiency Disclosure Certificate (BEEC). The BEEC includes a National Australian Built Environment Rating System (NABERS) Energy star rating, and owners must include this rating in any advertising material for the sale, lease, or sublease.

The Australian Government is considering a staged expansion of the CBD Program to other ownership structure, building types and sectors. Also under consideration are the types of energy and emissions information that should be disclosed. The department is consulting with the sector to inform this policy change. The consultation will include the publication of a KPMG report into Expanding the Commercial Building Disclosure Program.

Delivering this program will support the following Australian Government strategies:

- Net Zero Built Environment Sector Plan (under development)
- Net Zero in Government Operations Strategy
- Trajectory for Low Energy Buildings
- National Energy Performance Strategy.
